Metamark MD-PU2 is a 385 micron, semi rigid, 'Pop up' polyester, for use on solvent, Latex & UV inkjet printers. It has a bright white textured printable surface that is scratch resistant and an antistatic treatment that avoids attracting dust. The premium 'Pop up' material has a grey back offering 98% opacity. For use with modular 'Pop Up' display systems, for use in exhibitions and for POS. One part system for use without overlamination.

Handling and Printing

- Ensure that the material has reached room temperature and a relative humidity of 50% before printing.
- Do not handle the face film directly and ensure it is free from dust and static.
- Ensure that the correct profiles and heater settings are used. Most profiles are available for download from www.metamark.co.uk.
- The product is designed to be used without overlaminating.
- Do not stack prints until fully cured. If a take up roller is used then a silicon liner may be interleaved to prevent blocking.
- Allow the inks to cure before use, this is nominally 24-48 hours but dependant on the inks.
- The durability of the finished print is dependent on the inks and printer.
